

Special Business – Terms for Standcatering

1. These special business-terms are valid for all delivered service, and offers through Firm Lehrieder-Catering-Party-Service GmbH & Co. KG (Firm Lehrieder) MesseZentrum 1, 90471 Nürnberg, with representation through the Board of Directors – Jürgen Lehrieder, René Lehrieder, and Dr. Nadine Lehrieder in the area of Stand-catering. Deviation, contrary, or amendments to the general business-terms from the customer, will not be part of the contract.

2. Information of the Firm Lehrieder sortiments, packed goods, and price differences follow under the discrepancy of reasonable differences.

3. Telephonically with the customer, obligations are that after the request, you have the opportunity from the business-service (AGB) in written order with validity of the AGB in writing to confirm.

4. The price of the offer from the Firm Lehrieder is to be understood with the inclusion of the public-health insurance of the value added tax. This holds the price for two months after the offer-delivery has been made, individual offers of 30 days are binding where as the offer is not revoked. Then after, the price is subject to being sold.

5. The order of the customer can be opposite of the Firm Lehrieder without cost for one week, before the fair begins in writing without reverse. By resignation at customers request, less than one week before the fair must pay (80%) – (90%) of the full price by resignation after one day before the fair begins. The customer is in the knowing that the Firm Lehrieder is held liable only for minor damages.

6. The Stand-catering is constricted to the area of the fair grounds of the Nürnberg Messe. The delivery can not be transported through the place of the restaurants or Congress-room.

7. Delivered drinks: Drinks are commissioned through the Firm Lehrieder and refrigerated. The least amount taken is collected. Drinks are calculated after the consumption of use. The delivery is free for the first order of drinks, when ordered by afternoon, one day before the fair begins. During the continuation of fair time, if any additional drinks are ordered, then a transport fee of 10,00 Euro will have to be paid. After delivery the customer at anytime can give an order. At this time the Firm Lehrieder has executed their conditions.

For the drinks that are given back, you will receive a just fundamental from the Firm Lehrieder. Return is only in full boxes possible, and all other possibilities out of the question. The maximal total for full boxes given back is 30,00 Euro, and the Firm Lehrieder calculates per delivery an inclusive fee of 5,00 Euro. The customer has the right from the Firm Lehrieder to receive knowledge of the lump sum of the minor costs involved.

The non-returnable empty goods will not be taken back. The customer is obligated to give back the value return to the Firm Lehrieder. The empty goods with a deposit from the customer will not be compensated. Alternative would be that the Firm Lehrieder pays per empty box 5,00 Euro

including claim of damages. The customer has the right after the fact to receive from the Firm Lehrieder minor damages.

The customer has the right during and afterward upon completion of the fair to examine the object of consumption their-selves, and the delivered empty goods from co-workers from the Firm Lehrieder. There is no possibility of used or consumed drinks to be paid back from the Firm Lehrieder. The customer has the legal right to consumption information from the Firm Lehrieder and afterward the disprove of deduction.

8. Foods from the Firm Lehrieder after the amount ordered in accordance to the favourable price list are estimations. The least amount taken from the food list can only be ordered in quantities of 10 items per sortiment.

9. Reclamation in over mistaken amounts and not ordered articles are immediately from the Stand-catering retroactive from the Firm Lehrieder, and the customer notified. Later reclamation by mistake will not have the opportunity after, and can not be accepted.

The customer can check the delivered goods by the entrance to see of any defects are noticed, time of arrival, the amount, type, and condition. Immediately after delivery the Firm Lehrieder has to be notified of the entire amount. The items not known are distributed on your own. Without interruption the Entrepreneur must advertise the items in regards to the amount or defect, a claim of guarantee is out of the question. By order of wine, the choices of crystal, depot, or wine-stones are not defective.

The Firm Lehrieder lists the defected goods next to or after your choice, guaranteed for your acceptance of improvement or otherwise compensated. Other claims of the entrepreneur are out of the question. The subjected time period for understanding of a claim holds for one year after the delivery of goods.

The Firm Lehrieder contains itself so long as the customers deviation from the added usual transaction are replaced with the same type of quality, and amount for reasonable partial services. By wine age-group change is possible. Claims of customers out of legal warranty or when not accepted are in this frame out of the question.

10. Claim of damages by the customer are out of the question. When no deliberately or gross negligence handling or violation exist. Only by important injury are the Firm Lehrieder held liable, also for carelessness. This however is due to high unforeseen damages. There exist no claim for the customer of the Entrepreneur- claims of damages thirdly- as long as of special communicable and consequential damages. With understanding exclusion liability given also for employees, representatives, and accepted agent, Firm Lehrieder.

11. The Firm Lehrieder must be immediately paid and before departure from the fair in monetary or with credit card. The goods delivered are held ownership, until the amount is paid in full. The International exhibitor receives their statement of charges after the closing of the fair, and the amount must also be paid in monetary or with credit card. The Firm Lehrieder is entitled and

The open statements from the customer belongs only to Firm Lehrieder, when the counter claim of legal effectiveness are stabilized, undisputed or recognized. The same goes for a lein.

The customer is obligated by Firm Lehrieder before the fair begins the correct business-seat and the account address distributed. The Firm Lehrieder is entitled by the second sending to become the necessary statement of false address, a charged fee of 25,00Euro. The customer has the right to know the minor cost involved from Firm Lehrieder.

12. The customer, at the end of fair arranges delivery of rental's used from Firm Lehrieder. For customer to reach Firm Lehrieder, please call (tel: 0911-8606-6114.) By defected rental equipment or damaged, the customer's claim of damages are raised in value of service. Rental equipment unarranged for delivery is for Firm Lehrieder unpleasureable, and are entitled to personal cost of arrangement for the customer.

13. Fulfilled place of Fair: Nürnberg. Nürnberg venue compatibility, a place of orders acknowledged, with special business-terms.

Salvage clause: When service is ineffective, validity from other clauses are based. When one clause of service, only in one part is ineffective, then the other parts are invalid. The opponents are formulated, one ineffective clause through one effective, compensates to replace the near economical purpose of effective contract-terms.
